Pic-Time Ltd., and its affiliates (collectively, “**Pic-Time**”, “**we**”, “**us**” or “**our**”) value privacy rights. We will process your request within the time period required under applicable Data Protection Laws. Where permitted, we may extend this period by the amount of time allowed under applicable Data Protection Laws if your request is complex, if you submit multiple requests, or if we require additional information.

We will process your request free of charge. However, we reserve the right to charge a reasonable fee to cover certain administrative costs (for example, providing additional copies of the data) or to deal with requests that are manifestly unfounded or excessive.

Please note that you may not be entitled to exercise all or part of the rights described above. This depends on your jurisdiction, the applicable Data Protection Laws, our relationship with you, and any rights we may have under applicable law to refuse your request or to retain certain data. If we are unable to provide the information you requested or otherwise fulfill your request, we will endeavor to explain why and to inform you of any rights you may have.
